	Objectives	The objective of TPDS is to ensure availability of foodgrains to all bonafide citizens and to ensure that it is at price affordable for even the poorest in the State. With the implementation of the National Food Security Act, (NSFA), 2013, in the State with effect from February, 2016, the Act provides subsidized foodgrains to approximately two-thirds of the State Population.

	Eligibility criteria	Indigent Old Age Person above 65 years of age and not covered under the National Old Age Pension Scheme .		
	How to apply	The applicant may approach the concerned Deputy Commissioner, [S], / Sub - Divisional Officer, [S], for availing the Scheme.		
	Whom to contact	Deputy Commissioner, [S], / Sub - Divisional Officer, [S].or B.D.O. concerned.		
3.	Name of Scheme	Supply of Rice to ST / SC Hostels at BPL Prices.		
	Objectives	Under this Scheme Rice is supplied to inmates of ST / SC Hostels and Vocational Training Centre .		
	Services / Allowances	Rice :::		
		• For Hostel Inmates	::	At the scale of 15 Kgs per inmate per Month at the rate of ₹. 6:65 P per Kg.

4.	Name of Scheme	Consumer Protection.
	Objectives	Under the Provision of Consumer Protection Act, 1986 , Consumer Courts have been set up in Meghalaya , which are known as State Consumer Disputes Redressal Commission (State Commission) at the State Level and District Consumer Disputes Redressal Forum (District Forum) at the District Level .
	Services / Allowances	The District Forum deals with Consumer disputes the value of which ranges from ₹ 0 -- ₹ 20 Lakhs . The State Commission deals with Cases , value of which range from ₹ 20 Lakhs - ₹ 1 Crore .
	Eligibility criteria	Under the Provision of Consumer Protection Act, 1986 , a Complaint can be made in writing in the following circumstances :- <ul style="list-style-type: none"> • If you have suffered loss or damage as a result of any unfair trade practices by the Trader. • If the Good purchased suffer from any defect. • If the services hired / availed suffer from deficiencies in any respect. • If you have been charged a Price in excess of the Price displayed or fixed by or under any law for the time being in force. • The complaint is generally made in a Plain Paper.
	How to apply	The complainant may submit their complaints in plain paper.
	Whom to contact	The President State Consumer Disputes Redressal Commission and the President of District Forum concerned.
